**Re: Enbridge Gas Inc.
EB-2025-0155
EGI 2024 Deferral and Variance Account Disposition Application**

These are the submissions of the Ontario Greenhouse Vegetable Growers (OGVG) with respect to the above noted proceeding.

OGVG has reviewed the application, the interrogatory responses and Enbridge Gas Inc.'s argument in chief with respect to the proposed disposition of its 2024 deferral and variance accounts. In short, OGVG does not have any concerns with the proposed clearances.

OGVG notes that as its members are primarily contract rate customers, largely (albeit not exclusively) situated in the legacy Union rate zone, the result of Enbridge Gas Inc.'s proposal for the vast majority of OGVG's members is a refund. With respect to the accounts that a) relate to OGVG's members, b) are new (in that the calculation of the balance and the method of disposition have not been previously considered and approved by the OEB), and c) contain material balances, OGVG has not identified any concerns with the proposed disposition, or issues that would materially impact the result for its members.

OGVG recognizes that at least two parties, IGUA and OEB Staff, have made submissions with respect to the proposed approval of a 2026 Indigenous Working Group budget. OGVG takes no position on the proposed budget approval.
