## Issues:

Minogi is actively engaged in matters and issues related to Ontario's energy sector and the potential impacts on the Mississaugas of Scugog Island First Nation ("MSIFN"). MSIFN's Aboriginal and Treaty rights, land use, cultural heritage, and other rights and interests are potentially affected by the Proceeding. MSIFN has traditional territory, and associated rights and interests protected by s. 35 of the Constitution Act, 1982, that may be impacted by the outcomes of this proceeding. Minogi may, if granted intervenor status in this proceeding, address: (i) any proposed amendments to Sections 11, 12, and 15 of the Model Franchise Agreement; (ii) the constitutional duty to consult and accommodate; (iii) impact and consequences for Indigenous communities and Indigenous customers; and (iv) any other matters that promote or otherwise represent the interests of MSIFN more generally.

## Policy Interests:

Minogi represents the interests of MSIFN. Minogi therefore believes this question is not applicable to it, but it is available to provide further information on request.

## Hearings:

Minogi reserves its right to make submissions on the form of hearing following the interrogatory phase of the proceeding.

## Evidence:

Minogi does not currently expect to file evidence in this proceeding, but reserves its right to do so and will seek Board approval at the earliest opportunity.

## Coordination with Other Intervenors:

Minogi intends to be an active participant in this proceeding and will act responsibly to coordinate with other intervenors, as appropriate and where common issues may arise.

## **Cost Awards:**

Minogi hereby requests cost eligibility in this proceeding. Minogi is, in accordance with s. 3.03(b) of the Board's Practice Direction on Cost Awards, eligible to seek an award of costs as Minogi is a party that primarily represents an interest or policy perspective that is relevant to the Board's mandate and to the proceeding. Minogi represents the interests of a unique and otherwise unrepresented set of First Nation energy customers and consumers in Ontario pursuing clean energy opportunities associated with projects at or connected to OPG to further economic reconciliation. Minogi requests an award of costs in this proceeding on the basis that its participation serves a direct interest and policy perspective that is relevant to the Board's mandate and pressing for Ontario's energy consumers. The Board has granted Minogi cost eligibility in several Board proceedings, including each and all of those referred to above in Section 2. Minogi therefore submits that it is appropriate for the Board to award Minogi costs in the context of this proceeding, and hereby requests cost eligibility.
