Issues:

The OEB has consolidated this proceeding focused on the application made by EARTH Corporation to acquire Westario Power Inc. with the hearing of a separate application made by EARTH Corporation to acquire Tillsonburg Hydro Inc. (file number EB-2026-0145). Pollution Probe represents a consumer and policy interest related to these applications being heard in a consolidated manner. Pollution Probe intends to focus on consumer and community impacts related to the proposed acquisitions including rate impacts, distribution system plans, community energy planning and related policy issues.
