



Enbridge Gas Inc.

**Application for exemption from leave to construct
natural gas pipeline and associated facilities in the
Town of Amherstburg**

PROCEDURAL ORDER NO. 3

June 18, 2026

Enbridge Gas Inc. (Enbridge Gas) applied to the Ontario Energy Board (OEB) on August 9, 2024, under subsection 95(2) of the *Ontario Energy Board Act, 1998* (OEB Act) for an order exempting Enbridge Gas from the requirement to obtain leave to construct natural gas pipelines and facilities in the community of Boblo Island in the Town of Amherstburg.

Procedural Order No. 1, dated December 4, 2024, established a procedural schedule and approved Caldwell First Nation as a cost-eligible intervenor in the proceeding.

On May 14, 2026, the OEB issued its Decision and Order approving the application. The OEB's Decision and Order included a deadline of May 25, 2026, for Caldwell First Nation to file its cost claim in this proceeding, along with corresponding deadlines for any objection by Enbridge Gas and a reply from Caldwell First Nation.

On June 11, 2026 Caldwell First Nation filed a letter requesting an extension of time to file its cost claim, indicating that it was prepared to file on June 12, 2026. Caldwell First Nation noted that it had inadvertently missed the filing deadline. On June 17, 2026 Caldwell First Nation filed a follow-up letter of a similar nature.

The OEB approves Caldwell First Nation's request to extend the deadlines but notes that it remains the responsibility of the Caldwell First Nation to be aware of established deadlines and to plan accordingly to meet them.

As such, the OEB will also extend the deadlines for Enbridge Gas to file any objections to Caldwell First Nation's cost claim and for Caldwell First Nation to respond to any objections.

It is therefore necessary to make provision for the following matters related to this proceeding. Further procedural orders may be issued by the OEB.

IT IS THEREFORE ORDERED THAT:

1. Caldwell First Nation shall file with the OEB and forward to Enbridge Gas Inc. their cost claim in accordance with the OEB's *Practice Direction on Cost Awards* on or before **June 22, 2026**.
2. Enbridge Gas Inc. shall file with the OEB and forward to Caldwell First Nation any objections to Caldwell First Nation's claimed intervenor costs on or before **June 29, 2026**.
3. If Enbridge Gas Inc. objects to any Caldwell First Nation costs, Caldwell First Nation shall file with the OEB and forward to Enbridge Gas Inc. their response, if any, to the objections to cost claims on or before **July 7, 2026**.
