AFFIDAVIT OF ERYN MACKINNON

I, Eryn MacKinnon, of the City of Toronto, in the Province of Ontario, MAKE OATH AND SAY AS FOLLOWS:

1. I am employed as a Regulatory Advisor in the Regulatory Affairs Division of the Applicant, Hydro One Networks Inc.
2. Hydro One has complied with the Ontario Energy Board’s (**“OEB”**) Letter of Direction dated June 9, 2026, in respect of EB-2026-0128 (**the “Letter”**) as set out below.
3. In accordance with paragraph 1 of the Letter, Hydro One conducted a title search sufficient to determine the registered property owners and encumbrancers with lands or interests directly affected by the proposed application and related facilities refurbishments. I have been advised and do truly believe that this search has been completed as required.
4. In accordance with paragraph 2, subsection (a) of the Letter, Hydro One served the encumbrancers identified as having lands or interests directly affected by the proposed facilities refurbishments. The Notice package was delivered by courier and included a copy of the OEB’s English Notice, as well as the Application. A copy of the Notice package as sent to the described parties is attached at **Exhibit “A”**. A copy of the courier manifest is attached at **Exhibit “B”**.

5. In accordance with paragraph 2, subsections (b) through (i) of the Letter, an electronic copy of the Notice and the Application (Exhibit “A”) was served on the following:

- Hydro One transmission customers, generators, and electricity distributors impacted by the proposed refurbishment of the transmission line;
- Owners and operators of rail lines, telecommunications networks, and other utilities along or crossing the proposed route and location for the D6 Project;
- The clerks for the City of London (West);
- The clerks for the Municipality of Strathroy-Caradoc, Southwest Middlesex, Dawn-Euphemia, Chatam-Kent, and Lakeshore;
- Specified provincial ministries, agencies, and federal departments.

Hydro One Networks Inc. has applied for approval to build a high-voltage transmission line in Southwestern Ontario

Hydro One Networks Inc. (Hydro One Networks) is asking the Ontario Energy Board (OEB) for:

- Permission to construct 117 km of single-circuit 500 kilovolt electricity transmission line from Longwood Transformer Station to Lakeshore Transformer Station in southwestern Ontario in the area west of London.
- Permission to complete associated station facility expansions or upgrades at the terminal stations and minor grounding upgrades at six remote stations required for the connection of the new transmission line.
- Approval of the forms of land use agreements that Hydro One Networks will offer affected landowners.

Hydro One Networks says the project is required to increase long-term supply capability to support electricity demand growth in the Windsor-Essex and Chatham-Kent regions. The proposed transmission line has been designated as a priority project by the provincial government.

The OEB hearing is not the only approval process required before a line is built.

Environmental issues, or issues related to the Crown's duty to consult Indigenous peoples, are not part of the OEB's review unless there is a direct impact on price and the reliability and quality of electricity service.

A map of the proposed route for the transmission line is provided below:

There are three types of OEB hearings: oral, electronic and written. The applicant has applied for, and the OEB plans to proceed with, a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenor. After the hearing, we will decide whether to approve the application.

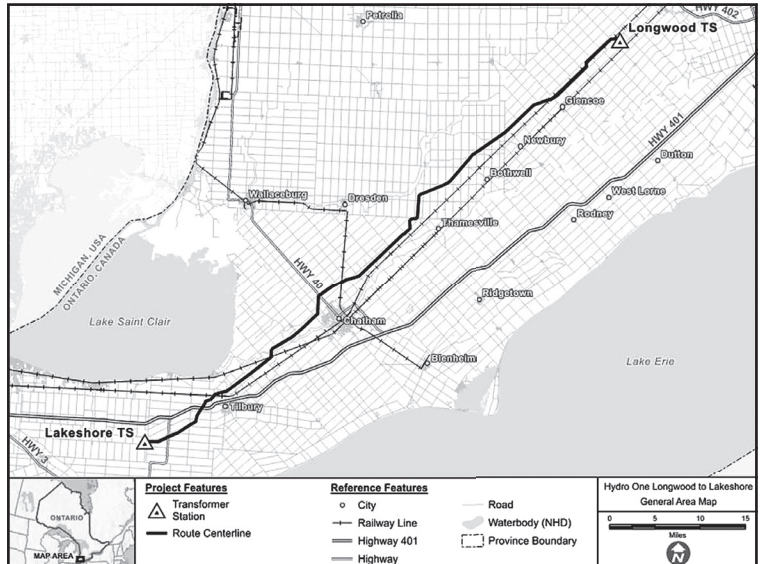

Hydro One Networks Inc. (Hydro One Networks) demande à la Commission de l'énergie de l'Ontario (CEO) de lui accorder :

- La permission de construire une ligne de transport d'électricité de 500 kilovolts à circuit simple de 117 km entre le poste de transformation de Longwood et le poste de transformation de Lakeshore, dans le sud-ouest de l'Ontario, dans la région à l'ouest de London.
- La permission d'effectuer les expansions ou les mises à niveau des stations connexes aux stations terminales et les mises à niveau mineures de mise à la terre dans six stations éloignées qui sont requises pour le raccordement de la nouvelle ligne de transport.
- L'approbation des documents d'entente d'utilisation des terres qu'Hydro One Networks offrira aux propriétaires fonciers touchés.

Hydro One Networks affirme que le projet est nécessaire pour accroître la capacité d'approvisionnement à long terme et soutenir la croissance de la demande en électricité dans les régions de Windsor-Essex et de Chatham-Kent. La ligne de transport proposée a été désignée comme un projet prioritaire par le gouvernement provincial.

En plus de l'audience de la CEO, d'autres processus sont requis avant de pouvoir construire une ligne.

Les questions environnementales ou les questions liées à l'obligation de la Couronne de consulter les peuples autochtones ne font pas partie de l'examen de la CEO, à moins qu'elles n'aient une incidence directe sur le prix et sur la fiabilité et la qualité du service d'électricité.

Un plan du tracé proposé pour la ligne de transport est fourni ci-dessous :

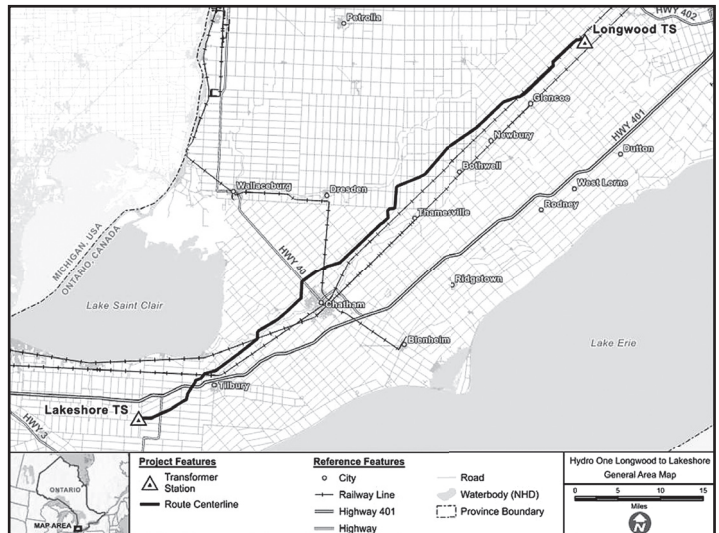

IN THE MATTER OF the *Ontario Energy Board Act*, 1998 (the “Act**”);**

AND IN THE MATTER OF an Application by Hydro One pursuant to section 97 of the Act for an Order granting approval of the forms of land use agreements offered or to be offered to affected landowners.

1. The Applicant is Hydro One, a subsidiary of Hydro One Inc. The Applicant is an Ontario corporation with its head office in the City of Toronto. Hydro One carries on the business, among other things, of owning and operating transmission facilities within Ontario.
2. Hydro One hereby applies to the OEB pursuant to section 92 of the Act for an Order or Orders granting leave to construct a new 500 kV single-circuit transmission line from Longwood TS to Lakeshore TS in the West of London area. The approximate length of the transmission line is 117 km.
3. In accordance with Order in Council No. 875/2022 and Minister's Directive ("Directive") issued March 31, 2022, the Minister of Energy directed Hydro One to develop and seek all necessary approvals for two new 500 kV single-circuit transmission lines from Longwood TS to Lakeshore TS, including associated station

1 facility expansions or upgrades required at the terminal station. Further, in
2 accordance with section 96.1 of the Act, and Order in Council No. 876/2022 that was
3 also issued on March 31, 2022, the Lieutenant Governor in Council declared the first
4 of these two 500 kV transmission lines as a priority project. Copies of the Orders in
5 Council and correspondence from the Minister of Energy to the OEB (dated April 4,
6 2022) to amend Hydro One's transmission licence in accordance with the Directive,
7 are found at **Exhibit B, Tab 3, Schedule 1, Attachments 1 to 3.**

8
9 4. The Project is required to increase long-term supply capability to support electricity
10 demand growth in the Windsor-Essex and Chatham-Kent regions while maintaining
11 the reliable and secure operation of the electricity system as recommended by the
12 IESO in its report titled the "*Supplemental Evidence to Support the Need for the*
13 *Longwood to Lakeshore Line 1 Project*". The IESO's report is provided as
14 **Attachment 6 in Exhibit B, Tab 3, Schedule 1.** The Project has been identified as a
15 non-discretionary development project in **Exhibit B, Tab 4, Schedule 1.**

16
17 5. The Project is subject to the applicable Class EA process in accordance with the
18 *Ontario Environmental Assessment Act*. On March 31, 2026, Hydro One filed the
19 Final ESR¹ and Statement of Completion with the MECP.

20
21 6. An overview map of the area is provided in **Exhibit B, Tab 2, Schedule 1,**
22 **Attachment 1,** and schematic diagrams of the proposed transmission facilities can
23 be found at **Exhibit B, Tab 2, Schedule 1, Attachments 2 to 4.**

24
25 7. Hydro One is committed to working with Indigenous governments and communities
26 in a spirit of cooperation and shared responsibility. Hydro One acknowledges that
27 Indigenous governments and communities have unique historic and cultural
28 relationships with their land and a unique knowledge of the natural environment.
29 Forging meaningful relationships with Indigenous governments and communities
30 based upon trust, confidence, and accountability is vital to advancing reconciliation

1 and achieving Hydro One's corporate objectives. Hydro One has been engaging with
2 Indigenous governments and communities since early in the development process
3 and will continue that engagement and involvement in project decisions throughout
4 the life cycle of the Project. Additionally, Hydro One has, and will continue to
5 throughout the life cycle of the Project, engage in economic participation negotiations
6 with impacted Indigenous communities including employment, training, contracting
7 and equity participation in the Project. To advance action on reconciliation, five local
8 First Nations will have the opportunity to invest in a 50 per cent equity stake in the
9 transmission line component of the Project through Hydro One's First Nations equity
10 partnership model. Hydro One expects that after completion of the Project, ownership
11 of the applied-for transmission line facilities will be transferred and owned by a limited
12 partnership that will include ownership interests held by the five First Nations. As of
13 the time of this Application, the limited partnership has not yet been finalized. As
14 negotiations are ongoing, Hydro One is not currently able to provide commercial
15 details. However, those details will be provided to the OEB once the limited
16 partnership is formed and through subsequent transmission licence and asset
17 transfer applications made to the OEB. In light of these circumstances, Hydro One is
18 proposing costs associated with the transmission line facilities are accounted for in
19 the OEB-approved ATP regulatory account² and not form part of Hydro One's rate
20 base. For reference purposes, further information on the ATP regulatory account is
21 provided at **Exhibit B, Tab 10, Schedule 1**. Hydro One is not anticipating the limited
22 partnership to impact the Project cost estimates provided at **Exhibit B, Tab 7,**
23 **Schedule 1**.

- 24
- 25 8. The forecast total capital cost of the Project transmission facilities is \$1,163.5 million³.
26 Details pertaining to these costs are provided at **Exhibit B, Tab 7, Schedule 1**.

- 1 9. The expected rate impact associated with the Project (using 2026 OEB-approved
2 uniform transmission rates as filed in **Exhibit B, Tab 9, Schedule 1**) is a \$0.46/month
3 increase on a typical residential customer's bill under RPP.
4
- 5 10. The 500 kV conductor selected by Hydro One to complete the Project has been
6 predicated on Hydro One's commitment to minimize transmission line losses where
7 feasible. Further information regarding the transmission line loss analysis for the
8 Project is provided in **Exhibit B, Tab 5, Schedule 1**.
9
- 10 11. The IESO has completed a Final SIA. The SIA concludes that the Project is expected
11 to have no material adverse impact on the reliability of the integrated power system
12 and recommends that a *Notification of Conditional Approval for Connection* be issued.
13 The IESO's Final SIA is provided as **Exhibit F, Tab 1, Schedule 1, Attachment 1**.
14
- 15 12. Hydro One has completed a Final CIA in accordance with Hydro One's connection
16 procedures. A copy of the Final CIA is provided as **Exhibit G, Tab 1, Schedule 1,**
17 **Attachment 1**. Hydro One will fulfill all requirements of the SIA and the CIA, and will
18 obtain all necessary approvals, permits, licences, certificates, agreements, and rights
19 required to construct the Project.
20
- 21 13. The proposed in-service date for the Project is December 2030, assuming a
22 construction commencement date of January 2027 and an OEB approval of this
23 Application by December 2026. A project schedule is provided at **Exhibit B, Tab 11,**
24 **Schedule 1**.
25
- 26 14. New permanent land rights on properties between Longwood TS and Lakeshore TS
27 will be required to accommodate the proposed 500 kV transmission facilities. The
28 Project will require Hydro One to acquire land rights from 342 directly impacted
29 properties. Temporary rights for construction purposes will also be required at specific
30 locations along the transmission corridor. These rights will be negotiated and

1 acquired as and when needed. Further information regarding the real estate needs
2 to complete the Project is provided in **Exhibit E, Tab 1, Schedule 1**.

3
4 15. This Application is also seeking approval of the forms of the agreement offered or to
5 be offered to affected landowners, pursuant to section 97 of the Act. The majority of
6 these agreements are in the same form as previously approved in prior Hydro One's
7 leave to construct proceedings. Any agreements that have not been previously
8 approved by the OEB or have been altered from their last approval have all been
9 explicitly identified in the Application. The forms of the applied-for agreements are
10 found as attachments to **Exhibit E, Tab 1, Schedule 1**.

11
12 16. The Application is supported by written evidence which includes details of the
13 Applicant's proposal for the construction of the proposed Project. The written
14 evidence is prefiled and may be amended from time to time prior to the Board's final
15 decision on this Application.

16
17 17. Based on the foregoing, and the information provided in the prefiled evidence, Hydro
18 One submits that the Project is in the public interest. The Project meets the needs of
19 the transmission system while maintaining reliability and quality of service, with
20 minimal impact on electricity prices.

21
22 18. Hydro One consents to the conditions set out in the OEB's standard conditions of
23 approval for electricity transmission leave to construct applications⁴ in respect to this
24 Project, and consents to the proceeding being held by way of a written hearing.

25
26 19. Acronyms and abbreviations are used throughout the prefiled evidence and those
27 acronyms and abbreviations are defined at **Exhibit A, Tab 1, Schedule 3**.

28
29 20. Hydro One requests that a copy of all documents filed with the Board be served on
30 the Applicant and the Applicant's counsel, as follows:
