We are counsel to the Distributed Resource Coalition ("**DRC**") in the above-noted proceeding (the "**Proceeding**"). Further to the Board's Decision and Order dated May 12, 2026, please find enclosed DRC's cost claim in respect of the Proceeding.

DRC respectfully requests an award of 100% of its eligible costs, given its strategic and principled participation in the Proceeding on behalf of otherwise unrepresented ratepayers with unique interests. DRC submits that this request is supported by the following considerations:

- (i) DRC participated effectively, taking a surgical, principled, and coordinated approach, in accordance with direction from the OEB for intervenor coordination, to the issues and undertaking coordination with other intervenors to avoid overlap and maximize efficiency in all aspects of the Proceeding, including close coordination with intervenors with similar interests in preparation for and during the Settlement Conference;
- (ii) DRC participated responsibly and made reasonable efforts to ensure that its participation was not unduly repetitive and was focused on relevant and material issues to its members and ratepayers; and
- (iii) DRC contributed to the Board's better understanding of issues in the Proceeding through interrogatories, by participating in the Technical Conference and Settlement Conference, and through its written submissions on the unsettled issues.

We trust that this approach maximizes efficient use of resources and the right of otherwise unrepresented distributed energy resource, electric vehicle and related ratepayers to be heard in a manner that is consistent with the Board's mandate and statutory objectives.

DRC respectfully requests a full award of eligible costs.
