Pollution Probe Cost Claim**

Dear Mr. Murray:

In accordance with OEB direction, please find attached Pollution Probe's Cost Claim for the above-noted proceeding. The Cost Claim was created via RESS which includes the information in the attached time docket.

Pollution Probe was an active participant for all activities during this proceeding, including the extended settlement process which ultimately led to an OEB approved settlement on most of the issues. Without disclosing specific confidential details of the settlement process, the extended settlement process included iterative analysis, stakeholder coordination and trade-offs that were required to achieve the settlement that was ultimately approved by the OEB.

Pollution Probe coordinated efficiently with all intervenors as appropriate, which included Community Action for Environmental Sustainability (CAFES) Ottawa. Having the ability to leverage the same consultant as CAFES Ottawa during this proceeding enabled several opportunities for coordination and reduced costs for Pollution Probe, which would not have otherwise been available. Use of the same consultant did not result in any double billing and Pollution Probe was able to split (generally on a 50% basis) certain costs incurred for activities during the proceeding. If different consultants were used, it would have resulted in a higher cost claim. This approach was successful and details on the activities where Pollution Probe was able to split certain costs with CAFES Ottawa are outlined in the attached time docket.

Although Pollution Probe is a discretely different organization from CAFES Ottawa, (e.g. different staff, governance and stakeholders), it was identified during development of final submissions that it could be a viable potential option to consolidate submissions into one consolidated document while retaining the positions and recommendations that are important to each party and their constituents. Consolidation of the information, positions and recommendations into a common submission was challenging, but it reduced the aggregate time required by the OEB and all parties to review the submissions. Overall, this was considered an appropriate approach and was also assisted by the fact that only three important issues

remained that were not resolved through the OEB approved settlement. It would not have been possible to attempt this approach with the broader list of issues outstanding.

We respectfully request cost recovery for the costs as detailed in the attached Cost Claim. Please reach out should you have any questions.
