Re: Oshawa PUC Networks Inc.
Application for electricity distribution rates and other charges beginning January 1, 2026
Ontario Energy Board File No.: EB-2025-0014

We are counsel to the Distributed Resource Coalition ("**DRC**") in the above-noted proceeding (the "**Proceeding**"). Further to the Board's Decision and Order dated May 28, 2026, please find enclosed DRC's cost claim in respect of the Proceeding.

DRC respectfully requests an award of 100% of its eligible costs, given its strategic and principled participation in the Proceeding on behalf of otherwise unrepresented ratepayers with unique interests. DRC submits that this request is supported by the following considerations:

- (i) DRC participated effectively in the Proceeding, taking a surgical, principled, and coordinated approach to the issues, in accordance with direction from the OEB for intervenor coordination, and undertook significant coordination with other intervenors to avoid overlap and maximize efficiency in all aspects of the Proceeding, including close coordination with intervenors with similar interests in preparation for and during the Settlement Conference and oral hearing;
- (ii) DRC participated responsibly and made reasonable efforts to ensure that its participation was not unduly repetitive and was narrowly focused on relevant and material issues to its members and ratepayers consistent with its Intervention Form; and
- (iii) DRC contributed to the Board's, other intervenors', and the applicant's better understanding of concerns and issues in the Proceeding, including improvements to the applicant's approach to identifying, funding, and reporting on distributed energy resources ("**DERs**"), electric vehicles, and Non-Wires Solutions, through interrogatories, by participating in the Technical Conference, Settlement Conference, and oral hearing, and through its written submissions on the unsettled issues.

We trust that this approach maximized efficient use of resources and the right of otherwise unrepresented DER, electric vehicle and related ratepayers and customers to be heard in a manner that is consistent with the Board's mandate and statutory objectives.

DRC respectfully requests a full award of eligible costs.
