Attached please find AMPCO's cost claim in the above proceeding.

Oshawa Power's 2026 cost of service application was multi-faceted with very significant bill impacts for all customers including GS 1,000 to 4,999 kW and Large Use customers. This proceeding was part of the OEB's interrogatory collaboration pilot. In AMPCO's view, this pilot resulted in additional time to develop, review and file interrogatories compared to the OEB's typical process.

AMPCO worked closely with other intervenor to consider the application, prepare interrogatories, and draft final submissions. AMPCO's representative was out of the country during the Oral Hearing and thus, was unable to attend.

AMPCO's participation was focused and comprehensive to be of assistance to the OEB. AMPCO respectfully requests reimbursement of its reasonably incurred costs as set out in its cost claim.
