AFFIDAVIT OF ERYN MACKINNON

I, Eryn MacKinnon, of the City of Toronto, in the Province of Ontario, MAKE OATH AND SAY AS FOLLOWS:

1. I am employed as a Regulatory Advisor in the Regulatory Affairs Division of the Applicant, Hydro One Networks Inc.
2. Hydro One has complied with the Ontario Energy Board’s (**“OEB”**) Letter of Direction dated July 3, 2026, in respect of EB-2026-0155 (**the “Letter”**) as set out below.
3. In accordance with paragraph 1 of the Letter, Hydro One conducted a title search sufficient to determine the registered property owners and encumbrancers with lands or interests directly affected by the proposed application and related facilities refurbishments. I have been advised and do truly believe that this search has been completed as required.
4. In accordance with paragraph 2, subsection (a) of the Letter, Hydro One served the encumbrancers identified as having lands or interests directly affected by the proposed facilities refurbishments. The Notice package was delivered by courier and included a copy of the OEB’s English Notice, as well as the Application. A copy of the Notice package as sent to the described parties is attached at **Exhibit “A”**. A copy of the courier manifest is attached at **Exhibit “B”**.

5. In accordance with paragraph 2, subsections (b) through (i) of the Letter, an electronic copy of the Notice and the Application (Exhibit “A”) was served on the following:

- Identified electricity distributors whose service area the proposed transmission line and related facilities will be located;
- Hydro One transmission customers and generators impacted by the proposed refurbishment of the transmission line and related facilities;
- Owners and operators of rail lines, telecommunications networks, and other utilities along or crossing the proposed route and location for the Project;
- The clerks for the City of Peterborough, Townships of Selwin, Township of Cavan-Monaghan, Township of Scugog, City of Kawartha Lakes, and Municipality of Clarington;
- All indigenous communities that have been consulted or with lands or interest in the lands directly affected by the proposed upgrade and construction of the transmission line and related facilities;
- All specified provincial ministries, agencies, and federal departments.

Copies of the email correspondence are attached at **Exhibit “C”**.

6. In accordance with paragraph 3 of the Letter, the English version of the Notice, the Application, and the Evidence were posted on Hydro One’s website on July 6, 2026. A copy of the website posting is attached at **Exhibit “D”**.

On June 12, 2026, Hydro One Networks Inc. (“**Hydro One**”) filed a leave to construct application with the Ontario Energy Board (“**OEB**”) seeking approval for an Order or Orders granting leave to construct approximately 55 km of 230 kilovolt double-circuit electricity transmission line facilities from Dobbin Transformer Station to Clarington Transformer Station located in eastern Ontario between the County of Peterborough and the Municipality of Clarington.

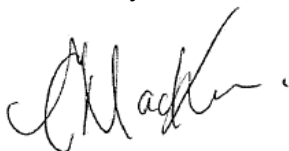

NOTICE OF A HEARING

Hydro One Networks Inc. has applied for approval to build a high-voltage transmission line in Eastern Ontario

Hydro One Networks Inc. (Hydro One Networks) is asking the Ontario Energy Board (OEB) for:

- Permission to construct approximately 55 kilometres of new 230 kilovolt double-circuit electricity transmission line from the Dobbin Transformer Station to the Clarington Transformer Station in Eastern Ontario. The Project would primarily be located within an existing transmission corridor.
- Permission to complete associated station facility expansions or upgrades at the terminal stations and minor protection upgrades at four remote stations required for the connection of the new 230 kilovolt double-circuit transmission line.
- Approval of the forms of land use agreements that Hydro One Networks will offer affected landowners.

Hydro One Networks says the project is required to increase the overall transfer capability of the bulk transmission system to ensure sufficient supply capacity to the Peterborough to Quinte West region and surrounding area. The proposed transmission line has been designated as a priority project by the Ministry of Energy.

The OEB hearing is not the only approval process required before a line is built.

Environmental issues, or issues related to the Crown's duty to consult Indigenous peoples, are not part of the OEB's review unless there is a direct impact on price and the reliability and quality of electricity service.

YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic and written. The applicant has applied for, and the OEB plans to proceed with, a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenor. After the hearing, we will decide whether to approve the application.

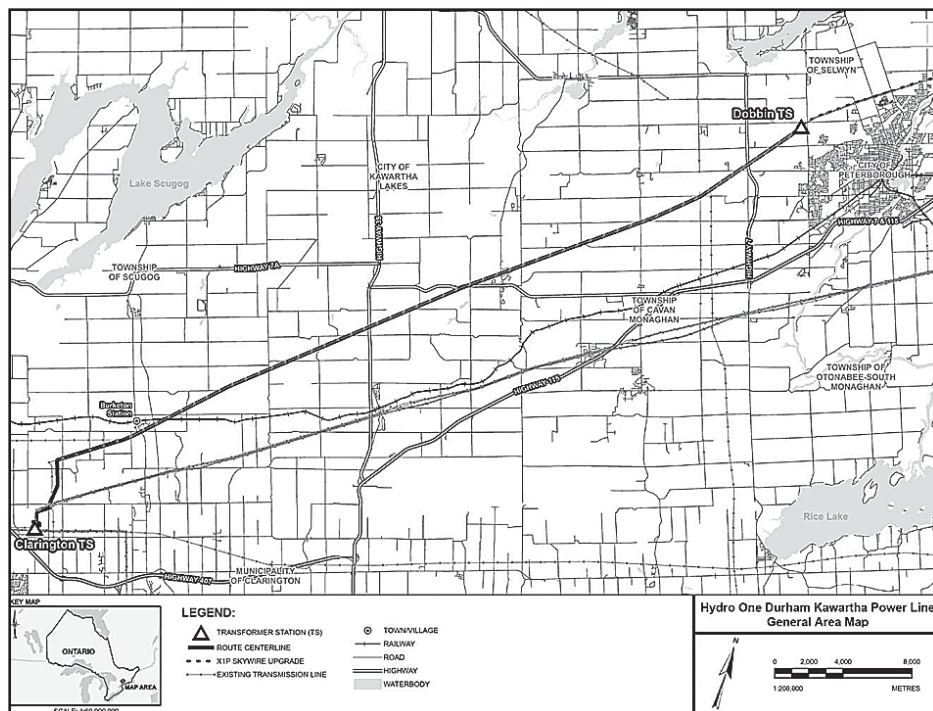

IN THE MATTER OF the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, Schedule B (the “**Act**”);

AND IN THE MATTER OF an Application by Hydro One pursuant to section 97 of the Act for an Order granting approval of the forms of land use agreements offered or to be offered to affected landowners.

1. The Applicant is Hydro One, a subsidiary of Hydro One Inc. The Applicant is an Ontario corporation with its head office in the City of Toronto. Hydro One carries on the business of, among other things, owning and operating transmission facilities within Ontario.
2. Hydro One hereby applies to the OEB pursuant to section 92 of the Act for an Order or Orders granting leave to construct a new 230 kV double-circuit transmission line from Dobbin TS to Clarington TS in Eastern Ontario. The approximate length of the transmission line is 55 km.
3. The Application is supported by written evidence which includes details of the Applicant's proposal for the construction of the proposed Project. The written evidence is prefiled and may be amended from time to time prior to the OEB's final decision on this Application.

- 1 4. Acronyms and abbreviations are used throughout the prefilled evidence and those
2 acronyms and abbreviations are defined at **Exhibit A, Tab 1, Schedule 3**.
3
- 4 5. In accordance with Order in Council No. 1532/2023 and Minister's Directive issued
5 October 19, 2023 ("**Directive**"), the Minister of Energy directed Hydro One to develop
6 and seek all necessary approvals for a new 230 kV double-circuit transmission line,
7 including associated expansions or upgrades required at the terminal stations.
8 Further, in accordance with section 96.1 of the Act, and Order in Council No.
9 1531/2023 that was also issued on October 19, 2023, the Lieutenant Governor in
10 Council declared the Project as a priority project. Copies of the Orders in Council and
11 correspondence from the Minister of Energy to the OEB (dated October 23, 2023) to
12 amend Hydro One's transmission licence in accordance with the Directive, are found
13 at **Exhibit B, Tab 3, Schedule 1, Attachments 1 to 3**.
14
- 15 6. The Project is required to increase the overall transfer capability of the bulk
16 transmission system to ensure sufficient supply capacity to the Peterborough to
17 Quinte West region and surrounding area, as recommended by the IESO in its report
18 titled the "*Gatineau Corridor End-of-Life Study*". The IESO's report is provided as
19 **Attachment 1** in **Exhibit H, Tab 1, Schedule 1**. The IESO further reaffirmed the need
20 for the Project in their supplemental evidence provided for the purposes of this
21 Application in **Attachment 6** of **Exhibit B, Tab 3, Schedule 1**. Given the above, the
22 Project has been identified as a non-discretionary development project in **Exhibit B,**
23 **Tab 4, Schedule 1**.
24
- 25 7. The Project is subject to the applicable Class EA process in accordance with the
26 *Ontario Environmental Assessment Act*. On January 30, 2026, Hydro One filed the
27 Final ESR¹ and Statement of Completion with the MECP.

1 8. An overview map is provided in **Exhibit B, Tab 2, Schedule 1, Attachment 1**, and
2 schematic diagrams of the proposed transmission facilities can be found at **Exhibit**
3 **B, Tab 2, Schedule 1, Attachments 2 to 4**.

4
5 9. Hydro One is committed to working with First Nations in a spirit of cooperation and
6 shared responsibility. Hydro One acknowledges that Indigenous governments and
7 communities have unique historic and cultural relationships with their land and a
8 unique knowledge of the natural environment. Forging meaningful relationships with
9 Indigenous governments and communities based upon trust, confidence, and
10 accountability is vital to advancing reconciliation and achieving Hydro One's
11 corporate objectives. Hydro One has been engaging with Indigenous governments
12 and communities since early in the development process and will continue that
13 engagement and involvement in project decisions throughout the life cycle of the
14 Project. Additionally, Hydro One has, and will continue to engage in economic
15 participation negotiations with impacted Indigenous communities throughout the
16 lifecycle of the Project, including through employment, training, contracting and equity
17 participation in the Project.

18
19 10. To advance action on reconciliation, impacted First Nations will have the opportunity
20 to invest in a 50 per cent equity stake in the transmission line component of the Project
21 through Hydro One's First Nations equity partnership model. Hydro One expects that
22 after completion of the Project, ownership of the applied-for transmission line facilities
23 will be transferred and owned by a limited partnership that will include ownership
24 interests held by the impacted First Nations.

25
26 11. As of the date of this Application, the limited partnership has not yet been finalized.
27 As negotiations are ongoing, Hydro One is not able to provide commercial details.
28 However, those details will be provided to the OEB once the limited partnership is
29 formed and through subsequent transmission licence and asset transfer applications
30 made to the OEB. In the circumstances, Hydro One proposes that the OEB-approved

ATP regulatory account² include the costs associated with the transmission line facilities instead of forming part of Hydro One's rate base. For reference, further information on the ATP regulatory account is provided at **Exhibit B, Tab 10, Schedule 1**. Hydro One is not anticipating that the limited partnership will impact the Project cost estimates provided at **Exhibit B, Tab 7, Schedule 1**.

12. The forecast total capital cost of the Project transmission facilities is \$428.2 million³. Details pertaining to these costs are provided at **Exhibit B, Tab 7, Schedule 1**.

13. The expected rate impact associated with the Project (using 2026 OEB-approved uniform transmission rates as filed in **Exhibit B, Tab 9, Schedule 1**) is a \$0.15/month increase on a typical residential customer's bill under RPP.

14. The 230 kV conductor selected by Hydro One to complete the Project has been predicated on Hydro One's commitment to minimize transmission line losses where feasible. Further information regarding the transmission line loss analysis for this Project is provided in **Exhibit B, Tab 5, Schedule 1**.

15. The IESO has completed a Final SIA. The SIA concludes that the Project is expected to have no material adverse impact on the reliability of the integrated power system and recommends that a *Notification of Conditional Approval for Connection* be issued. The IESO's Final SIA is provided as **Exhibit F, Tab 1, Schedule 1, Attachment 1**.

16. Hydro One has completed a Final CIA in accordance with Hydro One's connection procedures. A copy of the Final CIA is provided as **Exhibit G, Tab 1, Schedule 1, Attachment 1**. Hydro One will fulfill all requirements of the SIA and the CIA, and will obtain all necessary approvals, permits, licences, certificates, agreements, and rights required to construct the Project.

1 17. The proposed in-service date for the Project is December 2029, assuming a
2 construction commencement date of February 2027 and an OEB approval of this
3 Application by January 2027. A project schedule is provided at **Exhibit B, Tab 11,**
4 **Schedule 1.**

5
6 18. New permanent land rights on properties between Dobbin TS and Clarington TS will
7 be required to accommodate the proposed 230 kV transmission facilities. The Project
8 will require Hydro One to acquire land rights from 183 directly impacted properties.
9 Temporary rights for construction purposes will also be required at specific locations
10 along the transmission corridor. These rights will be negotiated and acquired as and
11 when needed. Further information regarding the real estate needs to complete the
12 Project is provided in **Exhibit E, Tab 1, Schedule 1.**

13
14 19. This Application is also seeking approval of the forms of the agreement offered or to
15 be offered to affected landowners, pursuant to section 97 of the Act. These
16 agreements are substantively consistent with the forms of agreement previously
17 approved in prior Hydro One leave to construct proceedings. Any agreements that
18 have been altered from their last approval have all been explicitly identified in the
19 Application. The forms of the applied-for agreements are found as attachments to
20 **Exhibit E, Tab 1, Schedule 1.**

21
22 20. Based on the foregoing, and the information provided in the prefiled evidence, Hydro
23 One submits that the Project is in the public interest.

24
25 21. The relief requested herein is required to increase the overall transfer capability of
26 the bulk transmission system to ensure sufficient supply capacity to the Peterborough
27 to Quinte West region and surrounding area. The Project will also provide flexibility
28 and resiliency in meeting future changes in demand and mitigate upstream thermal
29 constraints limiting flows into the Ottawa region. These outcomes are consistent with
30 the IESO's recommendations as set out in its bulk system planning report.

Furthermore, future assessments of the bulk and regional system requirements for Eastern Ontario are predicated on the completion of the Project.

22. The Project has been declared a priority project by the provincial government for purposes of section 96.1 of the Act. Accordingly Hydro One is undertaking development and seeking approvals for the Project as a condition of Hydro One's transmission licence consistent with the Minister of Energy's direction and associated Orders in Council.⁴

23. By locating the new transmission line facilities predominately within an existing transmission corridor, the Project reduces its land use footprint and minimizes impacts on both natural and socio-economic environments.

24. Additionally, approval of the Application will provide meaningful opportunity for Indigenous participation. On June 12, 2025, the Government of Ontario released *Energy for Generations*, an IEP which provides a 25-year roadmap for powering Ontario's growth and economic development in accordance with the province's Affordable Energy Future Vision.⁵ The IEP highlighted the importance of creating opportunities for meaningful Indigenous participation in energy projects. The Project is a collaboration that supports Indigenous-led economic development. As previously stated, Hydro One expects that after completion of the DKPL Project, ownership of the transmission line facilities will be transferred to a limited partnership owned by Hydro One and either directly, or indirectly, First Nations partners. It is in the public interest to support Indigenous partnerships, as stated in the IEP.

25. Hydro One requests:

- a) An Order or Orders pursuant to section 92 of the Act granting leave to construct the Project;

- 1 b) An approval of the forms of the agreement offered, or to be offered, to affected
2 landowners pursuant to section 97 of the Act; and
3 c) Such other relief as Hydro One may request or as the Board may direct.
4

5 26. Hydro One consents to the conditions outlined in the OEB's standard conditions of
6 approval for electricity transmission leave to construct applications⁶ for this Project.
7 Furthermore, Hydro One consents to the OEB proceeding by way of a written hearing
8 for this proceeding.
9
