We are counsel to Minogi Corp. ("**Minogi**") in the above-noted proceeding (the "**Proceeding**"). Pursuant to Procedural Order No. 2, please find attached the interim cost claims of Minogi in the Proceeding.

**Submissions.** Minogi respectfully request an award of 100% of its eligible interim costs, given its strategic and principled participation in the Proceeding to date. Minogi submits that this request is supported by the following considerations:

- (i) Minogi has participated effectively in the Proceeding, taking a surgical, principled, and coordinated approach to matters related to the rights and concerns of local First Nations and Indigenous communities and assisted in contributing to the Board's better understanding of such matters;
- (ii) Minogi has ensured that its participation in the Proceeding is focused on material issues and consistent with the scope of its intervention, as set out in its Intervention Form;
- (iii) Minogi has coordinated its intervention with other intervenors, including the other First Nation intervenor in the Proceeding, to participate cost-effectively, while advancing its own interests, in order to limit overlap and efficiently advance issues of mutual interest; and
- (iv) Minogi has participated responsibly and engaged with other intervenors and OEB Staff to avoid overlap, maximize efficiency, and ensure that its participation is not unduly repetitive and is focused on relevant and material issues.

We trust that this approach has maximized the efficient use of resources and the right of otherwise unrepresented and important First Nation and Indigenous energy stakeholders to be heard in a manner that is consistent with the OEB's mandate and statutory objectives.

Minogi respectfully request a full award of eligible costs.
