**EB-2007-0606/0615 – Combined Proceeding re Union Gas 2008 Rates and Enbridge Gas Distribution 2008 Rates Applications – Hydro One Networks Notice of Intervention**

Hydro One Networks Inc. ("Hydro One") is applying for late intervenor status in the above-noted proceeding. In doing so, Hydro One does accept the record as it now stands.

Hydro One is a subsidiary of Hydro One Inc. and operates extensive electricity transmission and distribution facilities throughout Ontario. Hydro One is a major stakeholder in the Ontario energy sector and a regulated Ontario electricity distributor and transmitter.
