**RE: EB-2025-0155 EGI 2024 Deferral Disposition Proceeding
FRPO Cost Claim**

We are writing on behalf of the Federation of Rental-housing Providers of Ontario (FRPO) to provide our cost claim in the above referenced proceeding.

As we have communicated a number of times recently, FRPO focuses its regulatory effort on assisting the Board with natural gas proceedings. In the current case, EGI was seeking disposition of deferral accounts related to its gas supply portfolio. Given the complexity of the recovery for these gas supply activities between commodity-related costs captured in the QRAM process and transportation-related costs captured through utility ratemaking and deferrals, FRPO invested in striving to ensure that ratepayers were not subject to a duplication of cost recovery. Without a technical or settlement conference, after interrogatories, we were reliant on research and review of past proceedings recently, and as long as a dozen years ago, to try to piece together the puzzle. In addition, FRPO pursued aspects of the application that other intervenors do not as they rely on our efforts.

We trust that our efforts were helpful to the Board in identifying gaps in evidentiary detail which we will strive to close in 2025 Deferral Disposition proceeding¹ expected soon. As such, we respectfully reimbursement of our reasonably incurred costs.
