Dear Jason Craig,

East Windsor (Expansion) L.P. filed an application with the Ontario Energy Board (OEB) on December 6, 2023, pursuant to section 60 of the Ontario Energy Board Act, 1998, for an electricity generation license. In its Decision and Order (EB-2023-034), the OEB approved the application, subject to the condition that the license would not take effect until the applicant provided written evidence confirming that construction of the facility had been completed and that the facility was ready to commence commercial operation.

On July 2, 2026, Capital Power sent a letter as written confirmation that East Windsor (Expansion) L.P. is scheduled to have completion of construction of the facility and achieve first sync to the grid between July 22 and July 28, 2026. The asset is then forecasted to being ready to commence commercial operation between September 15 and September 30, 2026. We therefore requested an electricity generation license be issued to East Windsor (Expansion) L.P.

On July 15, 2026, the OEB informed Capital Power via email advising that a license amendment request should be submitted to reflect the OEB's preferred approach of issuing licenses in the name of a general partner on behalf of a limited partnership, we understand that this approach aligns with the OEB's interpretation of the term "person" under the Ontario Energy Board Act, 1998, and the requirement that only a "person" may hold an OEB license.

Accordingly, we respectfully request that the electricity generation license be issued to 1000439737 Ontario Inc., in its capacity as general partner of and on behalf of East Windsor (Expansion) L.P. Attached is a list of

there are no financial statements for 1000439737 Ontario Inc and therefore we have provided the parent company.

The current schedule for the East Windsor Expansion facility anticipates first fire on July 27, 2026, followed by testing. Capital Power expects to submit the IESO Modelling, Data, and Analysis test results by August 31, 2026, and to receive confirmation of the Commercial Operation Date by September 30, 2026.
