NOTICE OF APPLICATION

UNION GAS LIMITED

LEAVE TO CONSTRUCT A NATURAL GAS DISTRIBUTION PIPELINE IN THE TOWNSHIP OF PUSLINCH, REGIONAL MUNICIPALITY OF WELLINGTON

Union Gas Limited ("Union") has filed an application with the Ontario Energy Board, (the "Board") dated November 13, 2008 under section 90 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c.15, Schedule B for an order granting leave to construct 4.9 kilometres of Nominal Pipe Size ("NPS") 12 steel pipeline in the subject area. The proposed pipeline is intended to transmit additional volumes of gas for the purpose of increasing the capacity of the existing Guelph System to accommodate forecasted growth on the system.

The Board has assigned File No. EB-2008-0364 to this application.

The proposed NPS 12 steel pipeline will extend north from the terminal point of the Guelph Phase I Looping project constructed in 2004 at Lot 16, Concession 1 along Wellington County Road 35, crossing Highway 401 to Lot 16, Concession 2, adjacent to Wellington Road 34. A map showing the location of the proposed route is attached as Appendix "A" to this Notice.

How to see Union's Application and Pre-filed Evidence

Copies of the application and the pre-filed evidence in support of the application will be available for public inspection at the Board's offices and at Union Gas Limited's head office.

How to Participate

If you would like to participate in this proceeding, please specify the application's Board File No. EB-2008-0364.

You may participate in this proceeding in one of three ways:

1. Send a Letter with your Comments to the Board

You may send the Board a letter of comment which will be provided to the Board members deciding the application, and will be part of the public record for the application. Your letter may include a request to make an oral presentation to the Board, and must be received by the Board no later than **30 days** from the publication or service date of this notice. The Board accepts letters of comment by either post or e-mail at the address below.

2. Become an Observer

Observers do not actively participate in the proceeding but monitor the progress of the proceeding. You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made in writing and be received by the Board no later than **10 days** from the publication or service date of this notice. If you become an observer, you need to contact the applicant and others in order to receive documents that they file in this proceeding and they may charge you for this. Most documents filed in this application will also be available on the Board's website. The Board accepts observer request letters by either post or e-mail at the addresses below; however, two paper copies are also required. You must also provide a copy of your letter to the applicant.

3. Become an Intervenor

You may request intervenor status if you wish to actively participate in the proceeding. Intervenors are eligible to receive evidence and other material submitted by participants in the hearing. Likewise, intervenors will be expected to send copies of any material they file to all parties to the hearing.

Your request must be made by letter of intervention and received no later than **10 days** from the publication or service date of this notice. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board may choose to hold either a written or an oral hearing. Your letter of intervention should indicate your preference for a written or oral hearing, and the reasons for that preference. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the applicant.
