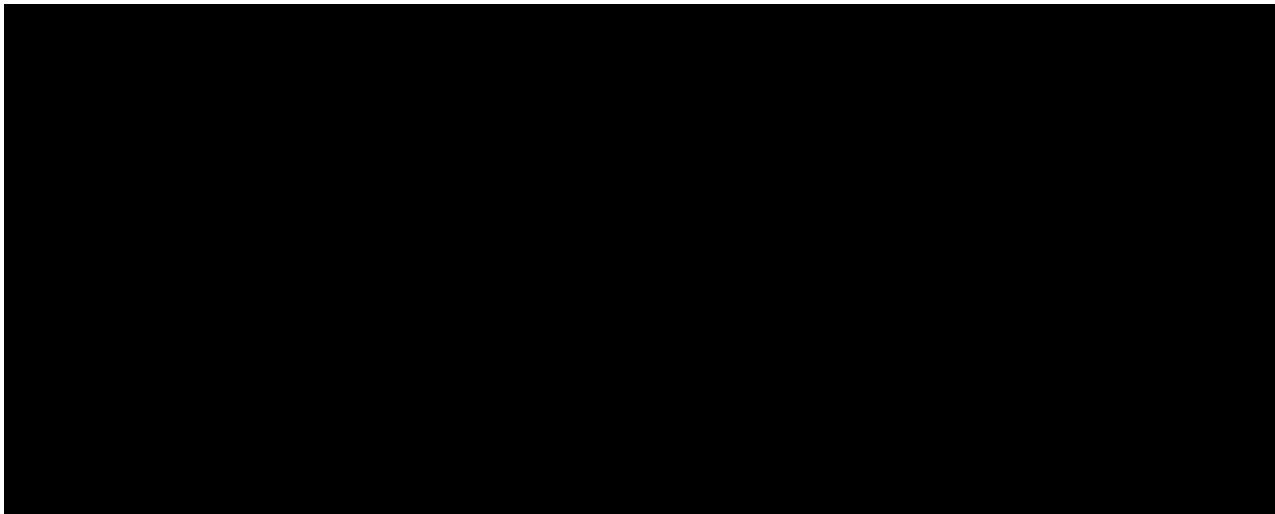

Issues:

Pollution Probe represents a consumer and policy interest related to Enbridge's 2027 rates application, which Enbridge has proposed to proceed in two phases. Pollution Probe was a party to the Phase 1, 2 and 3 Enbridge Rebasing proceedings and related OEB-approved settlement agreements which set the basis of this 2027 rates proceeding. All issues on the draft Issues List included in Enbridge's application pertain to the Decision and settlements from the Rebasing (Phase 1, 2 and 3) proceedings.
