

NOTICE OF A RATE HEARING

Newmarket-Tay Power Distribution Ltd. has applied to change its electricity distribution rates effective January 1, 2027

Newmarket-Tay Power Distribution Ltd. (Newmarket-Tay Power Distribution) has applied to the Ontario Energy Board (OEB) to change its electricity distribution rates effective January 1, 2027.

The requested rate adjustment is determined using an OEB-approved formula, which is tied to inflation and other factors intended to promote efficiency. If the application is approved as filed, a typical residential customer and a typical general service customer of Newmarket-Tay Power Distribution would see the following changes:

Customer Class	Newmarket-Tay Rate Zone	Midland Rate Zone
Residential (750 kWh)	\$0.80 per month	\$0.91 per month
General Service less than 50kW (2000 kWh)	\$1.74 per month	\$1.48 per month

Other customers, including businesses, will also be affected. It's important to review the application carefully to determine whether you may be affected by the proposed changes.

Newmarket-Tay Power Distribution has also requested:

- Extension of rate riders for the 2028 rate year associated with Lost Revenue Adjustment Mechanism eligible amounts and Metering Inside the Settlement Timeframe meter amounts.

YOU SHOULD KNOW

There are three types of OEB hearings: oral, electronic, and written. The OEB plans to proceed with a written hearing. If you think a different hearing type is needed, you can write to us to explain why.

During this hearing, we will hear questions and arguments from participants about this case. We will also hear questions and arguments from participants that have registered as Intervenor. After the hearing, we will decide whether to approve the application.

If you do not, the hearing will move forward without you, and you will not receive any further notice of the proceeding.

If you write a letter of comment, your name and the content of your letter will be put on the public record and the OEB website. If you are a business or if you apply to become an intervenor, all the information you file will be on the OEB website.
