**IN THE MATTER OF** the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B);

**AND IN THE MATTER OF** an application under section 74 of the *Ontario Energy Board Act, 1998,* S.O. 1998, c. 15, Schedule B to amend Ottawa River Power Corporation's distribution licence.

#### PROCEDURAL ORDER No. 1

Ottawa River Power Corporation ("Ottawa River") filed an application with the Ontario Energy Board (the "Board"), received on August 25, 2008, under section 74 of the *Ontario Energy Board Act, 1998,* S.O. 1998, c. 15, Schedule B. The Board has assigned File Number EB-2008-0289 to this application.

The Board issued a Notice of Application and Hearing on December 1, 2008. Brookfield Energy Marketing Inc.("Brookfield") applied for intervenor status. The Board has granted Brookfield intervenor status.

The Board has decided to proceed by way of written hearing and considers it necessary to make provision for the following procedural matters. Please note that this Procedural Order may be amended, and further procedural orders may be issued from time to time.

A list of parties to this proceeding is attached as Appendix A to this procedural order.

#### THE BOARD ORDERS THAT:

1. Parties who wish to receive information and material from Ottawa River that is in addition to Ottawa River's pre-filed evidence with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to Ottawa River on or before **January 16, 2009**. Where possible, the questions should specifically reference the pre-filed evidence.

- 2. Ottawa River shall file with the Board complete responses to the interrogatories and deliver them to the intervenor no later than **January 23, 2009.**
- 3. Parties who wish to make a submission must file that submission with the Board, and deliver it to the applicant and other intervenors by **January 30**, **2009**.
- 4. If the applicant wishes to file a response to a submission, the response must be filed with the Board and delivered to intervenors by **February 6, 2009**.

All filings to the Board must quote the file number, EB-2008-0289, be made through the Board's web portal at <a href="www.errr.oeb.gov.on.ca">www.errr.oeb.gov.on.ca</a>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.gov.on.ca. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
