Background

As summarized in the decision of the Board in the 2006 Rate Hearing, EB-2005-0001, of February 9, 2006, the applicant Enbridge Gas Distribution Inc. ("EGDI") originally contracted with Enbridge Commercial Services Inc. ("ECSI") in 2000 for customer care services. Effective January 1, 2002, the contract with ECSI was assigned to CWLP, which is a limited partnership between Enbridge Inc. and Kinder Morgan, Inc. (formerly Terasen Inc.). The CIS asset held by ECSI is licensed to CWLP, and CWLP has an agreement with Accenture to deliver services to CWLP's clients.

Matters related to EGDI's customer care costs and the CIS have been the subject of issues before the Board in prior rate hearings, and are included as Issue 7 on the Issues List for the 2007 Rate Hearing.

Scope of Intended Participation

CWLP seeks to intervene in this proceeding to ensure that it has timely notice of requests for information, ensure it can address information request in a timely manner, and can seek to protect its confidential information, as necessary.

CWLP intends to participate to the extent of attending at the hearing for matters related to Issue 7, obtaining written evidence, and the right to cross-examine and to make submissions in the proceedings, if appropriate.

CWLP is not intending to seek an award of costs.

CWLP is not seeking the right to deliver interrogatories.
